


Since the creation of man, God never did a miracle on Earth without participation from His creation. He created the animals, but Adam's job was to give them names. It was a sign of the authority He gave Adam on Earth. From then on, all other miracles required the Creator's partnership with the creation. This is why Paul affirms that we are God's fellow workers. (1 Corinthians 3.9)

Look at the partnership in dreams. When a desire is strictly according to the will of God, then that desire comes from God. And, just as He gives the vision, He also provides the means for the person to materialize it. Its materialization begins on the inside with acts of Faith. 2. Abraham left his land under the direction of God. As a result, God made him into a great nation;


3. In response to the direction of God, Moses stretched out his staff and touched the Red Sea. God sent a wind and separated it for His people to pass;

n a Saturday, Maria Eftfanoski, 56 years old, received a call informing her that her husband, Pedro, 56 years old, did not feel well as soon as he arrived at work. Shortly after arriving at work, Pedro passed out. There were 36 minutes without cardiorespiratory activity. His colleagues gave first aid, but he didn't react", describes Maria.

Pedro had a Cardiac arrest - his heart stopped pumping blood. It results in oxygen being unable to reach the brain, organs, and tissues. Resuscitation is possible when assistance comes quickly. But if it takes longer than 8 minutes, damage to the brain is considered prac-

tically irreversible.

Pedro got admitted to the hospital at 8:30 AM. At 11:30 PM, he was still unconscious. The medical report found that Pedro had a sudden death due to a cardiac arrest resulting from ventricular fibrillation, atrial fibrillation, and hypertrophic cardiomyopathy.

"At first, the doctors said that they could not do anything. The team gave care. a period of five days to a week for some reaction to happen," she says.

On the second day, however, they instructed Maria to sign the papers for organ donation. If Pedro survived, his chances of being vegetated were high. "But I knew that by my Faith in the Lord Jesus. People told me that it wasn't like that, that God helps, but that in Pedro's case, it was severe and would be impossible even for God. Yet I did not that's the word. I spent 36 minutes back down from my Faith. I knew God would heal him."

Maria continued acting in Faith, asking God for her husband's healing He helps us prevail", he concludes.

Pedro survived 12 days with the help of a life support machine. But He woke up on the 13th day, and by the 15th, Pedro was discharged, returning home, and continued to receive the necessary

WHEN ALL HOPE WAS GONE GOD DID THE MIRACLE

Everything was well with my son until one day, on a trip, he had an accident and suffered a severe blow to the head. After the accident, he was in excruciating pain and was vomiting. At first, we didn't think it was extreme, but when we went to the specialist, they told us it was an ear infection. He gave us instructions on how to treat it, but although we followed the instructions, we did not see any improvement.

As the pain was worsening and nothing we did was helping, we became desperate, so we took him to the hospital, and they tested him. When the results came out, it showed that he had a malignant tumor in an inoperable area of the brain. This news saddened the family, and the doctor advised that he should do



chemotherapy, and surgery had to be done on him. It was a complicated process, so much so that after several treatments, he could not take it anymore; he told us that he would rather die than continue with the treatments. He had to do another surgery but said he no longer wanted another operation. He no longer wanted to go to his consultations, and we, as parents, were losing hope.

Even though they said he needed another surgery, we were afraid because they said there were no guarantees that the surgery would go well.

At this point, we decided to leave the case in the hands of God as we knew that only a miracle could help him. We came to the Universal Church, and by hearing words of faith from the pastor, we chose to believe that God would heal my son. There they prayed for him, determining, with certainty, that he was already recovered from that tumor. It wasn't long before we went back to the doctor. Surprisingly, they said this new surgery was no longer required because the cancer was encapsulated, and there was no residue of it. SUNDAY GATHERING OF FAITH AND MIRACLES IN HARLEM, NY

The Universal Church in Harlem held its Sunday Gathering of Faith and Miracles at the AMC -Magic Johnson Theatres in Harlem, New York.

Bishop Joshua led the opening prayer asking God to perform a miracle in the lives of the Attendees since the Attendees were there to see God in their lives. He prayed that miracles would be performed inside the Attendees so they could see the changes in their lives. Bishop Joshua noted that sometimes individuals are alive, but the various areas of their lives are dead and living like

zombies; therefore, they need their lives resurrected.

As the scriptures say:

Jesus said to her, "I am the resurrection and the life. He who believes in Me, though he may die, he shall live. And whoever lives and believes in Me shall never die. Do you believe this?" John 11:25-26

Bishop then encouraged the Attendees to pray that the Spirit of the Lord may enter

their lives so their lives will be resurrected since start of the "Holy Week," which would close on our Lord Jesus is the resurrection.

Bishop Joshua also blessed the Attendees' waters. He prayed for the Attendees to be healed from incurable illnesses, sicknesses, and diseases. The Attendees then took three (3) sips of the blessed water utilizing their Faith and believing in their healing.

Blessed Water Testimony:

Ms. Lisa testified that before attending the church, she suffered from heart palpitations, a cyst on her spine of which she underwent a four (4) hour back surgery. In honor of Palm Sunday, the Attendees waved their Palm, symbolically welcoming

> our "Lord Jesus Christ into the service and our lives." Bishop Joshua instructed the Attendees to bring the Palm back to their houses to symbolize our Lord Jesus being welcomed into our

homes. It was the April 9th, 2023, Easter Sunday.

Video Testimony:

We then watched a video of Mr. Alexander, who testified of having a destroyed life before attending the church. He was unemployed and in debt; he would also rob and steal to feed his

drug habit and live a promiscuous lifestyle. He was lost and was without peace.

He noted that based on the bad coverage of the church in the various media outlets, he had a bad view of the church and even despised the church's work. He would persecute the church and its message, calling it a cult and Bishop Macedo a thief or

fraud. He noted that although he was persecuting

the church, the church grew, making him angrier.

In his quest for peace/help, he became an assistant to a witch doctor practicing witchcraft against the church and its Attendees. He did this for seven (7)

years without success against the church or having peace in his life. He finally got the courage to for the Faithful Tithers, asking attend the Universal Church. He was pleasantly surprised that he did not have to pay a fee to enter the church and that the members treated him with respect, love, and care.

After just one visit, he received the peace inside that he had been yearning for years. He began his journey with the Universal Church after that. "Doing something good for your family," even if they do not deserve it, resounded with her.



Many people face situations in which they see no way out. However, God recorded in the Holy Scriptures that you can achieve everything when resorting to supernatural faith: "With men this is impossible, but with God all things are possible." (Matthew 19.26). The impossible is called a miracle, and it happens when all human resources have already been used and are unsuccessful. That is, supernatural faith, which depends on complete trust in the power of God, must be practiced when ordinary faith no longer generates effects. ARE THEY REAL OR FAKE?

Doctors found tumors in five places on Maria's body. She still suffered a cardiac arrest and had a hospital infection. Hardly anyone believed in her healing.

She was diagnosed with five cancers. In 2018, bleeding took Maria to the hospital. She was accompanied by her husband, Luiz, who says that the doctor "suspected cervical cancer. The biopsy confirmed it."

Surgery to remove the tumor was performed, and there it was discovered that cancer had spread to the ovary, bowel, and bladder. Metastases (tumor cells) were removed.

The couple's daughter, Eliane, says that, upon receiving the news, she knelt and cried out to God for a miracle: "My faith would not accept it. It was the name of our God that was at stake. I took it into my heart that God would restore her health."

The family has been going to the Universal Church for 20 years; therefore, Eliane already went to the hospital with the blessed water. She recalls that her mother's drain was "pure blood."

"When I faced that situation, I continued to exercise faith and did not despair. I gave her the blessed water, and the drain began to clear four hours later. From then on, she only got better. After eight days, she went home," she reports.

Mary lost her sight and became paralyzed. She remained hospitalized for more than 50 days.

As Eliane reports, the doctors gave up on Maria: "They asked to take her home because there was nothing else to do. Not even the family believed there was a way out. But, inside me, I said there was a way in her case, and by faith, nothing was impossible." The family continued to attend the Universal Church, "and God heard our prayers," says Eliane.

Maria recalls how she felt after being discharged to die at home: "It was like the last straw. Everyone used their faith; they put the blessed water in my mouth. When I found myself and managed to understand the situation, I spoke to God: If the Lord has a miracle in my life, as soon as I can walk, I will go to the church to glorify Your name and thank You for everything I've been through."

Today her health is perfect. "The medical team still says there is no explanation. But I know what it was: it was a miracle from God. I am a living miracle," she closes.

I WAS ON THE BRINK OF **DEATH THREE TIMES!**

lthough he had a good childhood, Marcio says that he took a different path in his teens. "My routine has always been from school to home, but from 13 to 14, I got involved with some friendships. However, the same friends who played ball and flew a kite began to walk the paths of marginality, drug dealing, and theft. I got involved with petty theft until I got to shoplifting."

The consequences soon came. Marcio agreed to participate in the robbery of a pizzeria, but things did not go as planned. "The police arrived, and after trying to escape, I got arrested. They did everything for me to hand over who was with me, but I didn't do that.

At just 17, he had to pay for the crime of theft. Before being stopped, however, he had already known the result of bad choices. "Three times, I felt the possibility of death on my skin. On the first one, a guy pointed a gun at me. On the second, I was already hanging out with a gang. We did what we shouldn't, and, in return, the person started shooting. The last one, they confused me with a boy who was in debt with drug trafficking."

The robbery at the pizzeria happened on a Saturday. As he was underage, Marcio would be transferred to a juvenile detention center. "My father said he would never enter the prison system, but unfortunately, I put him through that. Behind bars, I saw who was with me because I didn't get a visit from anyone except my parents."

The transfer from the police station to the detention center, as he points out, was made on Tuesdays and Thursdays, but that did not happen with him: He was detained at the police station for 14 days. "I remember that the warden thought it was strange since he never saw a scene like that during the 15 years he was

there. He even asked if anyone never seemed to leave. "Within in my family messed with rituals because that situation was abnormal. That's when I remembered my mother's prayers, who attended the Universal Church. I remember that, on a Wednesday, I experienced talking with God, something I had never done before. I prayed: "If You exist, get me out of here because if I go there, I know I will kill or be killed."

Free and away from crime, he discovered himself in football. "I started riding for some teams in the junior category. At 21, I tried to become a professional in a team, but I gave up. I took a computer course to work in the area then, but I received an offer to play in the US and didn't go. I became a professional but didn't want to pursue a career anymore."

If good opportunities often hit the post, the agony inside him

me, things didn't work out: there was a huge disturbance, a void, a hole, but I couldn't take it anymore. One day I saw my sister getting ready to attend church, and I asked to go with her. It was a Wednesday like the one I first talked to God about six years ago. I confess I just wanted a prayer, but all the hurts and traumas I carried disappeared that day. I never left the church, where I have been for 16 years."

Gradually, Marcio's life began to change.

"I got married, my wife and I opened our own business and bought our apartment, but the greatest achievement I have is the Holy Spirit," he concludes.



kidnappings. I knew what I needed to do, my soul was very bitter, and I did not care.

My life on the streets began in the city I GREW UP IN. I SAW IT ALL AROUND ME, THE STREET WHERE I LIVED. I SAW PEOPLE USING DRUGS, DRINKING, ASSAULTS, FIGHTS, AND EVEN DEATHS. When I reached the age of eight, I had my FIRST CONTACT WITH DRUGS; IT WAS MARIJUANA THAT WAS MY ADDICTION. I WOULD ROB PEOPLE TO SUSTAIN MY HABIT.

There became a point when the marijuana wasn't enough for me anymore, so I started using cocaine. I liked the adrenaline I got from using cocaine, being on the street, living that reckless life of robbing etc. I LEARNED HOW TO USE GUNS. I had this wrong idea that I could commit THE "PERFECT" CRIME WITHOUT GETTING CAUGHT. Still, I had this mentality from within my house because my siblings were also involved in crime.



I did not care. One day, she took me in the car, and I asked her, "WHERE ARE YOU TAKING ME?" She replied, "You'll see very soon." She took me straight to jail, and she intended to try and scare expression, and the sadness on her face was so me. She thought that seeing these other boys there extreme; because of me. At 16, I got a girl pregnant.

in the jail cell, the guards, would put fear in me, and I would abandon this life. Contrary, I became worse. A month later, I committed a terrible assault on someone much older than me, which landed me in the same facility my mom had taken me to a month prior.



My father and mother came to visit me one day, and my father said, "I AM GOING TO ASK YOU THIS ONE QUESTION WHEN YOU GET OUT OF HERE ARE YOU GOING TO STOP WITH ALL OF THIS?" I looked my father dead in his eyes and said, "DAD, WHEN I COME OUT OF HERE, I WILL LEAVE THIS LIFE BEHIND." My day of freedom came, and I remember this day so well. When I arrived home, I went to go fight in the streets, I saw things I never imagined I would see. THIS DAY CAUSED MANY ENEMIES, AND PEOPLE WERE AFTER ME TO KILL ME.



My mother found bags of crack in the house, and I BECAME VERY PARANOID, LOOKING OVER MY SHOULDER AND EVEN THOUGHT OF KILLING MY MOTHER.

Things were terrible. I looked at my mother's

At this point, I heard voices, saw shadows, and was in a terrible state. To subside these voices, I would use a lot of cocaine and drink alcohol, but I intended to overdose and hopefully die.

ONE SUNDAY AFTERNOON, WHILE USING DRUGS, I got a visit from three people. I knew two OF THEM BECAUSE I USED TO SELL DRUGS TO THEM, BUT THIS TIME THEY NEVER CAME TO ME TO BUY. They came to invite me to join them at the Universal Church (UBB). They had become assistants in the church, and challenged me. I accepted the challenge and believed them because I saw their change.

I went to the church and didn't remember the pastor's words. I only remember he prayed for me, and I cried. It was a cry from my soul, but after this prayer, it was like the scale from my eyes was removed, and I asked myself, "WHAT ARE YOU DOING WITH THIS LIFE OF YOURS?" I decided to let go of this life. I left the church without any desire to use drugs.

I decided the next day to get baptized; I told myself this was a new chance to change my story. I heard about the Holy Spirit and how He is important. I desired the Holy Spirit greatly, the more I heard about Him, the more I wanted to know who He was, and I wanted to remain until the end. I didn't want to go back to a life of crime. I sought Him with all of me, and I thank God today, I can say I am a son of God. Before I would carry weapons, I was the leader of a gang, and now I am a child of God. How marvelous is this? I went from a life of crime to God's altar.





L tried to do everything with my strength. I lied to get what I wanted. I did the wrong things and thought it wouldn't catch up to me." Leda Sousa's life was like that for many years.

At the age of 20, Leda was faced with the fact that she had become a single mother. She spared no effort to succeed, but she always had difficulties despite all her efforts. According to her, the reason for this was that she always thought that, even doing what was wrong, in the end, it would end well.

But the reality was different, as she reveals: "My life was a complete humiliation. I had a dirty name, couldn't keep a job, and lost everything I had conquered. I got to the point where I owed three months of rent."

Faced with the threat of eviction, she took out a loan from a loan shark. But that solution soon put her and her entire family at risk; she received death threats daily.

Not knowing what else to do, she paid the debt by giving the loan shark her car. However, if, on the one hand, the problem with him was resolved, on the other hand, new difficulties arose: "Since I had lost my car, I got involved with the illicit business to earn money. I started falsifying documents and defrauding values, and I thought no one would notice. For me, deceiving people was the easiest way to make money, but my life kept going downhill."

The change began when Leda understood that her choices were the problem. "I was an unjust person, and I wanted justice. My word was worthless. I was a liar and did not honor my word," she recalls.

One day, Leda received an invitation from a work friend to go to the Universal Church. When she arrived at the church, she

understood she was not only robbing people but mainly God. "The Pastor started preaching about being faithful to God and honoring Him first. So, I learned that my life would be different if I put God above everything, becoming a faithful tither."

She learned through the services that for her life to change from the inside out, she would need God's character and the Holy Spirit living in her, and that is what happened. "Today I hate injustice because when we receive the Spirit of God, He guides us in the path of Truth and teaches us to be righteous. It is He who guides me in my decisions. I always tell God I can lose everything but not the Holy Spirit.

Today I have no difficulty doing what is right. I learned to be faithful to God in everything," she concludes.
